2. No person of firm shall submit more than one tender for the same item.
3. The tenderer must submit the tender form issued by the office in original, or download form website along with fees.
4. Tender documents, signed copy of the terms and conditions duly stamped along with requisite EMD in a sealed cover, in the office of the Dean, College of Agriculture Gwalior, 474002 preferably by registered of speed/post/courier up to 14.00 hrs of 09.11.2011
5. Belated tenders due to postal or any other delay will not be considered.
6. The EMD (Earnest Money Deposit) valid for six months from the date of issue should be in the form of A/C payee DD/ Bankers Cheque/ fixed deposit receipt of a nationalized / schedule Bank in favour of “Dean, College of Agriculture, Gwalior” payable at Gwalior. In absence of EMD in the prescribed form, the tender will not be considered. The EMD will be forfeited in case the tenderer fail to execute the order in specified time.
7. The tender offer should have validity for the financial period of 2010-11.
8. The rates quoted should be inclusive of all the Tax, F.O.R., village - Aisa, Tehsil – Ambah, distt.- Morena.
9. Each tender must be accompanied with the price list of the items failing which the tender will not be considered.
10. The tender will be opened on 09.11.2011 at 15.30 hrs by the members of the College level purchase committee in the Office of Dean, College of Agriculture, Gwalior 474002. The tenderer can depute his authorized representative to be present at the time of opening of the tenders.

12. The EMD shall be released after 50 days from the date of opening of the tender.
